

TERMS AND CONDITIONS

OF THE FAMILY RECREATION CLUB "NIEBIESKIE MIGDAŁY" (BLUE ALMONDS)

§ Check-in

1. Check-in from 14.00 (2.00) PM to 12.00 AM the next day.
2. The wish to extend your stay beyond the period indicated on the day of arrival, should be stated at the reception desk before 10.00 AM the day of the closing date of room rental. The Club will take into account the wish to extend your stay as far as possible.

§ Using the Room

1. The Guest is not allowed to relay the room to other people, even if the staying period, for which a fee was paid has not expired.
2. Persons who are not checked-in the Club can stay in a hotel room from 7.00 AM to 22.00 (10.00) PM.

§ Responsibilities

1. The Club is obliged to ensure the full and unfettered leisure of the Guest, safe staying, professional and courteous service, room cleaning and performing the necessary repairs during the absence of the Guest, in his presence only when he wishes, provide efficient support in technical terms; in case of defects which cannot be removed, the Club will endeavour to replace the room where possible or to mitigate the inconvenience in other way.

§ Cleanup rules of staying in the Club

1. The Club Guests are obliged to obey silence at night, the behaviour of Guests and people who use the services of the Club should not interfere with the staying of other Guests.
2. The Club may refuse to continue to provide services to a person who violates the principle of obeying these Terms and Conditions.
3. The club may refuse to provide services to the person for any reason.

§ Responsibility for property

1. Each time when leaving room, the Guest should check the door closing. The Guest is financially responsible for any damage or destruction of objects and technical facilities of the Club arising from his fault or the fault of people visiting him.
2. Loss of room key, is charged in the amount of PLN 50.
3. Due to fire safety, it is prohibited to use heaters, electric irons and other similar devices which are not the equipment of the room.
4. The Club's liability for loss of or damage to property brought by the Guest to the Club will be governed by the provisions of Article 846-849 of the Civil Code. The liability of the Club is restricted, if valuable items are not stored in the Club deposit.
5. The Guest should inform the hotel reception about the damage to the property of the Club or the property of the Guest immediately after the occurrence of such.
6. The Club is not responsible for damage to or theft of a car or other vehicle belonging to the Guest, left on the parking lot of the Club.

7. Items left in rooms by the departing Guests, after their consent, will be sent (at the expense of the recipient) to the indicated address. In a case of absence of such a disposition, the Club will store these items for a period of 1 (one) month. After this period, they will be transferred to a public or social purposes, or disposed of as waste.

§ Acceptance of Terms and Conditions

1. These Regulations are available at the Reception desk and rooms of the Club and is available on the website www.niebieskiemigdaly-okuninka.pl
2. Booking a stay at the Club constitutes an acceptance of these Terms and Conditions.

SMOKING IN THE WHOLE CLUB AREA IS STRICTLY PROHIBITED!
